Safe & Sound Hillsborough (S&SH) and the **FBI Tampa Citizens Academy Alumni Association (FBITCAAA)** partnered to help reduce and prevent the spread of community violence by honoring those that have gone above and beyond to help keep their neighborhoods safe. Individuals that have demonstrated exemplary grass roots leadership are recognized with the Safe & Sound Hillsborough Community Builder Award. The FBITCAAA is a non-profit organization and is separate and distinct from the FBI.

Nominees for awards may be volunteers or members of a recognized organization who demonstrate selfless dedication to improving the quality of life in their community. **A mini-grant of up to \$750 is awarded on behalf of each winner to “pay it forward” to a community project of their choice.**

- Nominees must be US Citizens or legal permanent resident aliens.
- **Nominees must agree to a background check by the FBI prior to award approval.**
- No self-nominations will be accepted.
- Nomination must include a letter addressing qualifications for nomination, including a description of projects or activities that the nominee has created or participated in to help their community.
- Nomination must include supporting documentation of the project or activity (i.e. photographs, articles, flyers, testimonials, etc.).
- Awardees will be notified in writing and invited to an award ceremony.

The award winners must grant Safe & Sound Hillsborough and the FBITCAAA the unconditional right to use any form of their likeness or any statements made in the nomination, or both, for any lawful purpose. The use of likeness and any statements made may include, but not be limited to publishing, televising, broadcasting, webcasting and copyrighting. A lawful purpose may include, but not be limited to, educational news, trade or publicity.
